

2nd GLOBAL TMMi SURVEY

- Scope: All assessed organizations in 2021 & 2022
 - more recent than 1st world-wide user survey
- Objective is to gain a more detailed understanding of
 - the TMMi users (market)
 - benefits of TMMi that certified organizations enjoy
 - reasons for adopting TMMi
 - problems & challenges encountered when applying TMMi.
- The questionnaire was updated with University partners
 - new topics: Al and Test Automation



2nd GLOBAL TMMi SURVEY

- 121 organizations invited to participate
 - survey was sent to client sponsor and lead assessor
- 97 organizations participated impressive 80% response
- Confidence level of 95% to the information provided
- Based on the above factors, the results are a reliable indication to the performance of TMMi Globally


TOP 10 REASONS FOR TMMi AND BENEFITS REPORTED






